Valuation of Tata Steel

- Developed a comprehensive financial Excel model incorporating revenue forecasts, expenses, and capital structure
- Conducted industry research and financial analysis to derive intrinsic value by calculating terminal value, enterprise value, and equity value
- Estimated the stock price to range between Rs. 140 and Rs. 145 per share
- Recommended a hold position, resulting in a 12% return over a 6-month period

ACADEMIC PROJECTS

Financial Analysis

- Conducted a comprehensive financial analysis, focusing on window dressing parameters like correlation between receivables and sales, cash from operations, operating profit, and tax rate
- Evaluated quality metrics such as Sales CAGR, Operating Profit CAGR, and ROCE exceeding WACC, along with valuation metrics including CMP to Relative Price ratio, PVGO, PEG ratio, and Earnings Yield
- Performed a detailed ratio analysis using liquidity, solvency, inventory, profitability, leverage, efficiency, and market ratios, along with Common Size and DuPont analysis

Analysis of Active vs Passive Investing in Nifty Midcap 100

- Analysed quarterly returns of passively managed fund replicas against the Nifty Midcap 100 index, investing Rs. 20,000 in paper money per stock from June 2008 to March 2024
- Adjusted closing prices for corporate actions, including bonus issues, share splits, mergers & acquisitions, and dividend decisions
- Found the portfolio's CAGR to be 25.01%, confirming that passive investing outperforms in the long term, while active investing is more effective
 in the short term

Fundamentally Strong and Momentum-Based Portfolio Optimization

- Selected fundamentally strong, undervalued stocks and filtered those with positive momentum and created a portfolio of 5 stocks (i.e. Bajaj Auto, Adani Power, CG Power, L&T Tech, Coal Ind.)
- Optimized the portfolio by varying weights to achieve the best Sharpe ratio
- Evaluated risk through a variance-covariance matrix and plotted the efficient frontier and CAL
- Results: Outperformed the benchmark

Back Testing on Renko Chart using Martingale

- Conducted Back-Testing (June 2023 February 2024): Applied Renko chart analysis on HDFC Bank and DLF, with a 0.5% brick size, entering trades on green candles post-red series, and targeting 16 bricks
- Results: Achieved a profit of ₹3,200 on HDFC Bank and ₹700 on DLF

Back Testing of Buy on Breakout

- Breakout Strategy Analysis: Applied a "buy the breakout" strategy on four stocks and two indices (i.e. Apollo Hospital, BHEL, EMAMI, IDFC, FINNIFTY, BANKNIFTY), buying if the fifth day's price exceeded the highest of the last 4 trading days and selling if it was lower than the lowest of the last 4 trading days
- Results: Found a significantly higher success rate in long trades compared to short trades. Overall success rate was significantly low
